ORDER

WHEREAS, the institution, namely, 5mt. Amrit Kunwar Mahavidhaylayo, Atara Kalan (Jalaun), U.P. has applied for permission to start B.P.Ed. course with annual intake of 50 students (One Unit) from academic year 2003-2004. This institution also made separate application dated 17,06,2003 for recognition to start B.Ed. course from academic session 2003-2004.

AND WHEREAS, the original Fixed Deposit Receipt (FDR) No. TD/C 690969 dated 15.5.2004 issued by Allahabad Bank, Babai, Jalaun submitted towards Endowment Fund in 8 Ed. course, on inquiry it was confirmed to have been subsequently altered from Rs. 50,000/- (Rupees Fifty Thousand) and by subsequent alteration it was made for Rs. 5,50,000/- (Rupees Five Lacs and Fifty Thousand) and the matter being of serious nature punishable under various sections of Indian Penal Code, the NRC in its 88" meeting, being satisfied of the forgery having been committed, decided to cancel/reject both the applications of the institution and also to initiate criminal proceedings by lodging first Information Report.

AND THEREFORE, the above application of Smt. Amrit Kunwar Mahavidhaylaya, Atara Kalan (Jalaun), U.P. for permission to start B.P.Ed. course stand rejected accordingly.
