WHEREAS, the institution, namely, Smt. Amrit Kunwar Mahavidhaylaya, Atara Kalan (Jalaun), U.P. vide covering letter dated 23.06.2003 has made application dated 17.06.2003 under section 14(i) NCTE ACT, 1993, read with regulations, 2002 for recognition to start B.Ed. Course from academic session 2003-2004

AND WHEREAS, the institution submitted original Fixed Deposit Receipt (FDR) No. TD/C 690969 dated 15.06.2004 issued by Allahabad Bank, Babai, Jalaun towards Endowment Fund, which on preliminary scrutiny and verification appeared to have been altered. On further inquiry into the matter it was confirmed that the above FDR was initially for Rs. 50,000/- (Rupees Fifty Thousand) and by subsequent alteration it was made for Rs. 5,50,000/- (Rupees Five lacs and Fifty Thousand).

The matter being of serious nature punishable under various sections of Indian Penal Code, after providing reasonable apportunity to the concerned institution and being satisfied of the forgery having been committed as above, the NRC in its 88th meeting has decided to cancel/reject the above application of the institution and also to initiate criminal proceedings by lodging First Information Report.

AND THÉREFORE, the above application of 5mt. Amrit Kunwar Mahavidhaylaya, Atara Kalan (Jalaun), U.P. for recognition to start B.Ed. course is hereby rejected.
