ORDER

WHEREAS, the institution, namely, Gautam Buddha Degree College, Sahiyaur, Majhila, Konnauj(U.P.) vide covering letter dated 19.12.2002, has made an application, under section 14(1) NCTE Act, 1993, read with the NCTE Regulations, 2002 for recognition to start B.Ed. course with an annual intake of 60 students from academic session 2003-2004.

As required by the NCTE Regulations, 2002 towards Endowment Fund for Rs. 5,00,0007- (Rupces Five Lacs only) the institution submitted six fixed Deposit Recipts bearing numbers 183596, 183597,183598,183599,183600 and 036055 issued by Farrukhabad Gramin Hank, Branch - Agains and Meharpura. On scrutiny and verification of the above FDRs it was naticed that the amounts both in figures and words, were altered from Rs. 50,0007- (Rupees Fifty Thousand only) in total, to Rs. 5,00,0007- (Rupees Five lacs only) in total. On further inquery, the Chairmon, Farrukhabad Gramin Bank, Fotshgarh vide letter dated 15,04,2004 has confirmed that total amount of the above FDRs was Rs. 50,0007- (Rupees Fifty Thousand).

AND WHEREAS, after disclosure of the aforesaid forgery/alteration in valuable documents, the above institution was served with Show Cause Natices, under section 14(3)(b) of the NCTE Act, 1993, dated July 16, 2004 and November 01, 2004 providing reasonable opportunity in compliance to the decision taken by NRC in its meetings and to make written representation, if any, with in 30 days. When nothing was heard, a further reminder was sent to the Manager of the institution in compliance to the decision taken by NRC in its 86% meeting. Even thereafter no reply/explanation has been given by the institution against the proposed action.

AND WHEREAS, the entire matter was considered by NRC in its 88th meeting and on careful perusal of the original file of the institution and taking into consideration the provisions of the NCTE Act. Rules and Regulations made therein from time to time and legal opinion obtained in the matter, the committee decided to cancel/reject the above application of the institution and initiate criminal proceedings by lodging the First Information Report.

AND THEREFORE, the above application of the institution Gautam Buddha Degree College, Sahiyaur, Majhilo, Kannauj, U.P. stands rejected accordingly.
