## ORDER

For the purposes and in pursuance of the provisions contained in Section 13 of the NCTE Act. 1993, NCTE Headquarters conducted inspection of the Maharaja Surajmal Teacher Training Callege, Mahal Khas Fort, Bharatpur, Rajasthan - 321001 on 19.07.2003 and after having received the report/findings from the inspection team and seeking response of the institution on the deficiencies reported by the inspection team, the same are forwarded to the office of NRC to take further necessary action in accordance with the provisions of the NCTE. Act. Rules, Regulations etc. The deficiencies pointed out are as under:

- (i) The accommodation being utilized for the course has hardly four classrooms
- (ii) Accommodation is inadequate and not as desired to make the system operational.
- (iii) The library / activity room / labs are all shared with B. Pharma being simultaneously run by the institute. It is really difficult to identify the infrastructural procured for B. Ed. separately.
- (iv) All teachers working are not qualified and no approval has been sought / processed from the University concerned.
- (v) The payment of non teaching staff is made in cash.
- (vi) At the stage when the appointment of Principal / teachers is not in order, there seems to be completely misuse of public funds.
- (vii) The management should complete the construction work of the building for B. Ed. course at the narliest, in order to bring the activities fully operational.
- 2. AND WHEREAS, the said report of the inspection team and the reply of the institution were placed before the NRC in its 80% meeting. Having considered the same; the Committee was of the opinion that the reply and supporting documents attached therewith are not satisfactory. Therefore, the Committee decided that a show Cause Notice be issued to the institution under section 17 (i) of the NCTE Act, 1993, Accordingly, a Show Cause Notice dated 08.08.2004 was issued to the institution, communicating therein the deficiencies observed by the visiting team on inspection made by it under section 13 of the NCTE Act, 1993, to provide reasonable apportunity of making representation against the proposed action.
