ORDER

For the purposes and in pursuance of the provisions contained in Section 13 of the NCTE Act. 1993. NCTE Headquarters conducted inspection of the Bhupol Nobles College of Physical Education, Udaipur - 303001. Rejesthen on 2107.2003 and after having received the report/findings from the inspection team and seeking response of the institution on the deficiencies reported by the inspection team, the same are forwarded to the office of NRC to take further necessary action in accordance with the provisions of the NCTE, Act. Rules. Regulations etc. The deficiencies pointed out one as under:

- (i) Seven out of the list of fourteen lecturers provided by the institution do not have NET / SLET or equivalent qualification.
- (ii) The appointment of teachers in the institution has not been approved by the affiliating University.
- (iii) The Library is poor and journals on physical education are not being subscribed.
- (iv) The institution does not have facilities for anatomy and physiology lab.
- (v) The Education Technology Lob alongwith hardware and software is not available. Electronic publications on CD-Roms are also not available. The students of the M.P. Ed. programme are not being given any exposure to educational technology.
- (vi) Ten out of fourteen teaching staff is being paid a meager consolidated salary which is not in accordance with the NCTE norms.
- (vii) The treathers on consolidated solaries are not being paid for the vacation period.
- (viii) The Endowment Fund has not been put under joint operation with a representative of NRC/NCTE.
- (ix) It is also not clear as to whether the institution has made any arrangements of part time coaches for specialization offered, and a Medical Officer.
- 2. AND WHEREAS, the said report of the inspection from and the reply of the institution were placed before the IJRC in its 80° meeting Howing considered the same, the Committee was of the opinion that the reply and supporting documents attached therewith are not satisfactory. Therefore, the Committee decided that a Show Cause Notice be issued to the institution under section 17 (i) of the INCTE Act, 1993. Accordingly, a Show Cause Notice dated 06.08.2004 was issued to the institution, communicating therein the deficiencies observed by the visiting team an inspection made by it under section 13 of the INCTE Act, 1993, to provide reasonable opportunity of making representation against the proposed action.
