ORDER

For the purposes and in pursuance of the provisions contained in Section 13 of the NCTE Act, 1993, NCIE Headquarters conducted inspection of the Smt. Narayani Devi Verma Women's Physical T.T. College, Mahila Ashram. Shilwara, Rajasthan - 311001 on 22,07,2003 and after having received the report/findings from the inspection ream and seeking response of the institution on the deficiencies reported by the inspection team, the same are forwarded to the office of NRC to take further necessary action to accordance with the provisions of the NCTE. Act. Rules, Regulations sec. The deficiencies pointed out are as under:

- The institution does not have required number of full time regular (1) lecturers, as laid down in the NCTE, norms.
- Nine out of the list of lecturers provided by the institution do (11) not have NET / SLET or equivalent qualification.
- The appointment of teachers in the institution has not been (111) approved by the affiliating University.
- As the institution runs more than one programme from the some (IV) pramises, the space available for the B. Ed. section is not sufficient for proper conduction of the programme.
- Laboratories are ill-equipped and appear to be out of use. (v)
- The Computer Lab has only three PGs that in without occassories (VI) and adequate software support for an intake of 160 students.
- The institution has not maintained an Endowment fund of Rs. 5.00 (1114) Lacs. The fund has not been put under joint operation with a representative of NRC/NCTF.
- (viii) The institution has not maintained the required Reserve Fund.
- It is also not clear as to whether the institution has made any arrangements of part time teachers for tracking Art and Croft, (ibe) Music_Physical Education etc.
- AND WHEREAS, the said report of the inspection team and the reply of the institution were placed before the NRC in its 80th meeting. Having considered the same, the Culamities was of the upinion that the reply and supporting documents oftached therewith one not satisfactory. Therefore, the Committee decided that a Show Cause Notice he issued to the institution under section 17 (i) of the NCTE Act, 1993, Accordingly, a Show Cause Notice dated 06.08.2004 was issued to the institution, communicating therein the deficiencies Contd. 2.
