## ORDER

For the purposes and in pursuance of the provisions contained in Section 13 of the NCTE Act, 1993, NCTE Headquarters conducted inspection of the Bhartiya Vidya Mandir Shikshak Prashikshan Mahavidyala, Dayalab Rood, Banswara, 327001 on 21.07.2003 and after having received the Rajasthan report/findings from the inspection feam and seeking response of the institution: on the deficiencies reported by the inspection team, the same are forwarded to the office of NRC to take further necessary action in accordance with the provisions of the NCTE, Act, Rules, Regulations etc. The deficiencies pointed out are as under:

The Institution does not have required number of full time regular lecturers, as laid down in the NCTE norms.

For out of the list of lecturers provided by the institution do not (11) have NET / SLET or equivalent qualification.

The appointment of the teachers in the institution has not yet been (iiii) approved by the affiliating University.

Laboratories are ill-equipped and appear to be out of use. (iv)

The Computer Lab has only three PCs that to without accessories (v) and adequate software support for an intake of 120 students.

The institution does not have playground facilities. (vi)

The Endowment Fund has not been put under joint operation with the (vii) representative of the NRC/NCTE

The teachers are reported to be on a consolidated meager salary and nd in accordance with the scales prescribed by the Central/State Government or the UGC.

It is also not clear as to whether the institution has made any (IX) arrangements of part time teachers for teaching Art and Craft. Music, Physical Education etc.

AND WHEREAS, the said report of the inspection team and the reply of the Institution were placed before the NRC in its 80th meeting. Having considered the same, the Committee was of the opinion that the reply and supporting documents attached therewith are not satisfactory. Therefore, the Committee decided that a Show Cause Notice be issued to the institution under section 17 (i) of the NCTE Act, 1993. Accordingly, a Show Couse Natice dated 06.08.2004 was issued to the institution, communicating therein the deficiencies observed by the visiting teem an inspection made by it under section 13 of the NCTE Act. 1993, to provide reasonable opportunity of making representation against the proposed action.
