ORDER

For the purposes and in pursuance of the provisions contained in Section 13 of the NCTE Act. 1993. NCTE Headquarters conducted inspection of the Geeta Bajaj Mahila Shikshak Prashikshan Mahavidyalya. Moti Doongri Circle. Jaipur. Rajasthan on 22.07.2003 and after having received the report/findings from the inspection team and seeking response of the institution on the deficiencies reported by the inspection team, the same are forwarded to the office of NRC to take further necessary action in accordance with the provisions of the NCTE, Act. Rules. Regulations etc. The deficiencies pointed out are as under:

- (i) Out of ten lecturers appointed, five do not have NET qualification.
- (ii) The list of teaching staff has not been approved by the offiliating University.
- (iii) The teachers are being paid poor consolidated solaries and not in accordance with the scales prescribed by the State/ Central Government or the UGC.
- (iv) The institution does not maintain adequate Reserve Fund.
- (v) The Endowment Fund has not been put in joint operation with a representative of NRC/NCTE.
- 2. AND WHEREAS, the said report of the inspection team and the reply of the institution were placed before the NRC in its 80" meeting. Having considered the same, the Committee was of the opinion that the reply and supporting documents attached therewith are not satisfactory. Therefore, the Committee decided that a Show Cause Notice be issued to the institution under section 17 (i) of the NCTE Act, 1993. Accordingly, a Show Cause Notice dated 08.08.2004 was issued to the institution, communicating therein the deficiencies observed by the visiting team on inspection made by it under section 13 of the NCTE Act, 1993, to provide reasonable appartunity of making representation against the proposed action.
- 3. The reply submitted by the institution was placed before NRC in its 85th meeting, whereby the NRC decided that clarification be sought from the institution asking them to submit a written representation alongwith supporting documents duly authenticated alongwith an an Affidovit signed by authorized functionary of the Management with regard to the Show Cause Notice dated 08.08.2004.
