- (b) The countersigned statement of all faculty members from the Director, SCERT should be submitted before the commencement of the academic session.
- The institution shall adhere to all the other regulations and guidelines as framed by NCTE from (c) time to time
- (d) Before storting the course the institution should seek prior permission of the competent authority for conducting the exams and approval of the curriculum that they are going to adopt for the course.
- (e) Institutions if starts the training programme without prior approval/permission of competent authority/examining body regarding the curriculum they have adopted and conduct of examination for award of Diploma/Certificate the recognition of such institutions shall be
- (f) Non-compliance of the above mentioned conditions shall cause action under section 17 (1) of NCTE Act, 1993.
- The Recognition is subject to the condition that the affiliating body shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / State Govt. / Affiliating body.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like SCERT/ State Government, etc.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating body / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
