## ORDER

District Institute of Education and Training, Hapur, Ghaziabad -245101, U.P. submitted on application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for an additional intake of 100 seats in BTC course of Two Year duration in terms of section 15(1) of NCTE Act 1993.

- Now, therefore, in exercise of the power's vested under Section 15(3)(a) of the NCTE Act, 1993. the Regional Committee hereby grants recognition to District Institute of Education and Training. Hapur, Ghaziabad -245101, U.P. for an additional annual intake of 100 seats in 1st year and some for the IInd year of two year duration BTC Course (100 existing + 100 additional + Annual Intake 200 seats) w.e.f. 23rd April 2005 subject to compliance of the following Conditions before the commencement of the academic session.
- Appointment of the faculty members duly qualified and staff as per the norms of NCTE/ State Boyt /SCERT is to be completed before the commencement of the session.
- The countersigned statement of all faculty members from the Director, SCERT should be (b) submitted before the commencement of the academic session.
- The institution shall athere to all the other regulations and guidelines as framed by NCTE from (c) time to time.
- Before starting the course the institution should seek prior permission of the competent (d) authority for conducting the exams and approval of the curriculum that they are going to adopt
- Institutions if starts the training programme without prior approval/permission of competent (c) authority/examining body regarding the curriculum they have adapted and conduct of examination for award of Diploma/Certificate the recognition of such institutions shall be
- Non-compliance of the above mentioned conditions shall cause action under section 17 (1) of (f) NCTE Act, 1993.
- The Recognition is subject to the condition that the affiliating body shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / State Govt. / Affiliating body.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like SCERT/ State Government, etc.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating body / State Directurate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
