ORDER

District Institute of Education and Training, Faridpur, Distr. - Bareilly-243503, U.P. submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for an additional intake of 100 seats in BTC course of Two Year duration in terms of section 15(1) of NCTE Act, 1993.

- Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to District Institute of Education and Training. Faridpur, Distr. Bareilly -243503, U.P. for an additional annual intake of 100 seats in 1st year and same for the IInd year of two year duration BTC Course (100 existing + 100 additional Annual Intake 200 seats) w.e.f. 23rd April 2005 subject to compliance at the following Conditions before the commencement of the academic session.
- (a) Appaintment of the faculty members duly qualified and staff as per the norms of NCTE/ 5 tate 6 ovt./SCERT is to be completed before the commencement of the session.
- (b) The countersigned statement of all faculty members from the Director. SCERT should be submitted before the commencement of the academic session.
- (c) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- (d) Before starting the course the institution should seek prior permission of the competent authority for conducting the exams and approval of the curriculum that they are going to adopt for the course.
- (c) Institutions if starts the training programms without prior approval/permission of competent authority/examining body regarding—the curriculum they have adopted and conduct at examination for award of Diploma/Certificate the recognition of such institutions shall be withdrawn.
- (f) Non-compliance of the above mentioned conditions shall cause action under Section 17 (1) of NCTE Act, 1993.
- 3 The Recognition is subject to the condition that the affiliating body shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / State Gavt. / Affiliating body.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like SCERT/ State Government, etc.
- 5. The institution shall submit to the Regional Committee a Self Approisal Report at the end of each academic year along with a copy of the approval of the affiliating body / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant
