ORDER

Sukdeo Prasad Tripathi Mahavidyalaya, Vill. & Post - Bhathahin Khurd via - Fazil Nagar, Dist. - Kushinagar (UP) submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for B.Ed. course of one Year duration in terms of section 14(1) of NCTE Act, 1993.

- Now, therefore, in exercise of the powers vested under Section 14(i)(a) of the NCTE Act, 1993, the Regional Committee hereby grant recognition to Sukdeo Prasad Tripathi Mahavidyalaya, Vill, & Post Bhathahin Khurd via Fazil Nagar, Dist. Kushinagar (UP) for an annual intake of 100 seats (One Hundred only) in B.Ed. course of One year duration with effect from 21th May 2005 subject to compliance of the following conditions before the commencement of the academic session:
 - (a) Appointment of the faculty members duly qualified and staff as per the norms of NCTE/ State Govt,/UCC is to be completed before the commencement of the session.
 - (b) The countersigned statement of all faculty members from the Registrar of the concerned. University should be submitted before the commencement of the academic session.
 - (c) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
 - (d) The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
 - (e) That the Reserve Fund for an amount equal to three months salary of the Teachers & Statishe created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five years) in a Nationalized Bank.
 - (f) Non-compliance of the above mentioned conditions shall cause action under section 17 (1) of NCTE Act, 1993.
- The Recognition is subject to the condition that the affiliating University shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / UCC / Affiliating University.

 Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like U.G.C and State Government, etc.
