### ORDER

Ambrish Sharms College of Education and Technology, Village - Ghasipur , Hapur Road, Meerul, Uttar Fradesh submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for BTC of Two Year duration in terms of section 15(1) of NCTE Act, 1993.

- Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Ambrish Sharma College of Education and Technology. Village - Ghosipur , Hapur Road, Meerut, Uttor Pradesh for an annual intake of 50 seats (Fifty Only) (50 seats in the 1" year and the same for the II'd year in BTC course of two year duration with effect from 29th January 2005 subject to compliance of the following Conditions before the commencement of the ocudenic session.
- Appointment of the finality members duly qualified and staff us per the norms of NCTF/ State. Govt/SCERT is to be completed before the commencement of the session
- The countersigned statement of all family members from the Director, SCERT should be submitted (b) before the commencement of the academic session.
- The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time (c) to time.
- The institution shall within one month of the receipt of Recognition order, convert the Endowment (d) Fund account unto a Joint Account in the form of FDM for a period of not less than 60 months (Fine. years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
- That the Reserve Fund for an amount equal to time months salary of the Teachers & Staff be (e) created within one month from the date of issue of this order and maintained in the form of FDR in fovour of the management/institution, for a period of not less than sixty manths (Five years) in a Nationalized Bank.
- Before starting the course the institution should seek prior permission of the competent authority (f) for conducting the exams and approval of the curriculum that they are going to adopt for the course.
- Institutions if storts the training programme without prior approval/permission of competent (g) authority/examining body regarding the curriculum they have adapted and conduct of examination for eword of Diploma/Contificate the recognition of such institutions shall be withdrown.
- Non-compliance of the above mentioned conditions shall couse action under section 17 (1) of NCTE
- The Recognition is subject to the condition that the affiliating body shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / State Govt. / Affiliating body,
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like SCERT/ State Soverment, etc.
