ORDER

Usha Educational Institute, Agra Mathura Highway, Beri crossing, Farnh, Mathura (U.P.) had applied to Northern Regional Committee, National Council for Teacher Education for seeking recognition of the B.P.Ed. course, from the academic session 2004-2005 vide latter dated 30,12,2003.

- After the institution was inspected on 15.86,2004 & further on 11.09,2004 for verification of availability of infrastructural and instructional facilities and to enquire on the complaints received against the Institution as per decision of NRC taken in its 83rd meeting, the matter was considered by NRC in its 84th Meeting on the basis of original file of the invitation. VTRs received, forther clarification received from the expens teams, various complaints received against the Institution, other related documents, Act of NCTE 1993, Regulations and guidelines of NCTE published from time to time, Committee decided that the Institution, in the light of provision contained in section 15(3)(b) of the NCTE Act, 1993 be given an opportunity for making a written representation w.r.t. following deficiencies noted by the Committee:—
 - (a) Only 800 books have been added for B.P.Ed. course, which are not sufficient for running the seacher training programme effectively.
- 3. On receipt of the written representation submitted by the institution vide letter dated 25.30,2004, the case was further placed before the NRC in its 85° meeting. After careful parasal of the original file of the institution, VTR, other related documents, written representation submitted by the institution in support of documentary proof. Act of NCT1, 1993. Regulations and guidelines of NCTB published from time to time laid on the table of the committee, the Regional Committee noted that four complaints were received in the office of NRC against the institution. Accordingly it was decided that the representative of the institution be asked to appear before the Regional Director alongwith sit the original documents related with institution so that the same could be verified by the Legal Counsel of NRC.
- And as per this decision of NRC, the Chairman of the institution visited this office along with related documents on which opinion was obtained by this office from the legal counsel.
- 5. The whole case was again considered by NRC in its 87th meeting held on 28th & 29th January 2005 by examining all the relevant documents including original file of the institution. VTR, written representation submitted by the institution, affidavit submitted by the institution in support of documentary proof, various complaints from different quarters, Legal Opinion given by Legal counsel on the entire matter, order received from office of the Chancellor of the University, other related documents. Act, of NCTE, 1993, Regulations and guidelines of NCTE published from time to time, the Regional Committee finally decided that the application of the institution for B P.Ed. course cannot be considered as the land of the institution has been mortgaged with the Bank against loan advanced by it.

- In view of aforesaid decision the applicant Institution and other concerned bodies are advised not to admit any student in R.P.Ed. Course in the said institution keeping in view the provisions of section 17(4) of the NCTE Act, 1993 which stipulates that "the qualification in tencher education obtained pursuant to such course or training or after undertaking a course or training in such institution shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government."
- Further if the institution is not satisfied by the order, they may prefer to appeal to NCTE. Headquarters, Wing-II, Hans Bhawan, Bhadur Shah Zafar Marg, New Delhi -110002against this order under section 18 of the NCTE Act, 1993 within 60 days of the date of issue of this order. The guidelines of appeal are enclosed herewith.
