ORDER

Usha Educational Institute, Agra Mathura Highway, Beri crossing, Farah, Mathura (U.P.) had applied to Northern Regional Committee. National Council for Teacher Education for seeking recognition of the B.T.C. course from the academic session 2004-2005 vide letter dated 30.12.2003.

- After the institution was impected on 11.09.2004, the case was considered by the Northern Regional Committee in its 83th & 84th meeting on the basis of inspection report, further clarification received from the expert team, original file of the institution, copy of the NCTE Act, 1993, copy of the Norms and Standards and other related documents. Committee decided that the institution, in the light of the provisions contained in section 15(3%b) of NCTB Act, 1993, be given an opportunity for making a written representation w.c.t. following deliciencies noted in the case: -
 - Only 1000 books have been added for BTC course, which are not sufficient for running the teacher training programme effectively.
- On receipt of the written representation submitted by the institution vide letter dated 25.10.2004, the case was further placed before the NRC in its 850 meeting. After careful perusal of the original file of the institution, VTR, other related documents, written representation submitted by the institution, affidavit submitted by the institution in support of documentary proof. Act of NCTE, 1993, Regulations and guidelines of NCTH published from time to time laid on the table of the committee, the Regional Committee noted that four complaints were received in the office of NRC against the institution. Accordingly it was decided that the representative of the institution be asked to appear before the Regional Director alongwith all the original documents related with institution within, so that the same could be verified by the Legal counsel of NRC
- And as per this decision of NRC, the Chairman of the institution visited this office alongwith related documents on which opinion was obtained by this office from the Legal Counsel.
- The whole case was again considered by NRC in its 87th meeting held on 28th & 29th January 2005 by examining all the relevant documents including original file of the institute, VTR, written representation submitted by the institution, affidavic submitted by the institution in support of documentary proof, various complaints from different quarters. Opinion given by Legal counsel on the entire matter, order received from office of the Chancellor of the University, other related documents, Act, of NCTE, 1993, Regulations and guidelines of NCTE published from time to time, the Regional committee finally decided that the application of the institution for BTC course cannot be considered as the land of the institution has been mentgaged with the Bunk against loan advanced by it. In view of aforesaid decision the applicant Institution and other concurred bodies are advised not to admit any student in BTC Course in the said institution keeping in view the provisions of section 17(4) of the NCTE Act, 1993 which stipulates that "the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government."
- 7. Further if the institution is not satisfied by the order, they may prefer to appeal to NCITE Headquarters, Wing-II, Hans Bhawan, Bhadur Shuh Zafur Marg, New Delhi -110002against this order under section 18 of the NCTE Act, 1993 within 60 days of the date of issue of this order. The guidelines of appeal are enclosed herewith.
