**ORDER**


The Institution has been granted recognition by NRC, NCTE vide order dated 27.06.03 for B.Ed. course of one year duration.

2. And whereas the Institution vide letter dated 06.08.2004 informed the NRC, NCTE that it has shifted its premises from the present address i.e. Ward No. 3, Pratap Nagar, Hamirpur to the newly constructed building of college at V & PO - Jhanari, Dist. - Hamirpur - 177001, Himachal Pradesh.

And whereas, this matter was placed before NRC in its 85<sup>th</sup> meeting whereby NRC decided to conduct inspection of the infrastructural, instructional facilities in the new site, under section 17 of the NCTE Act 1993. Accordingly the inspection of the Institution was conducted on 24.12.2004 and the Visiting Team Report was considered by the NRC in its 87<sup>th</sup> meeting, wherein the NRC decided that the recognition of the Institution shall be continued on usual terms and conditions and this change of address be communicated to all concerned.
