- 2. AND WHEREAS, NRC in its 89th meeting, in proceedings initiated under Section 17 of NCTE Act, 1993, decided to withdraw the above order granting recognition to the institution for Shiksha Shastri course: Pursuant to it, a formal order dated 29.04,2005 was issued by the office of NRC.
- AND WHEREAS, since National Council for Teacher Education vide its order dated
   09.06.2005, in an appeal preferred before it, has reversed the above order of NRC.
- 4. AND THEREFORE, in pursuance of the order of NCTE, the NRC withdraws its order dated 29.04.2005 and the order issued by this office dated 24.07.2000 granting recognition to the institution for Shiksha Shastri course is restared to continue and remain in force till further orders.
