ORDER

For the purposes and in pursuance of the provisions contained in Section 13 of the NCTE Act, 1993, NCTE Hatrs, conducted inspection of Smt. Mahadevi Mahilla Teachers Training College, Narainpur, Dist. - Alwar (Rajasthan) on 23.07.2003 and ofter having received the report from the inspection team and seeking response of the institution on the deficiencies reported by the inspection team, the same were forwarded to the office of NRC to take. further necessary action in accordance with the provisions of the NCTE, Act, Rules, Regulations. etc. The deficiencies pointed out are as under-

- (i) The Principal is not qualified as per NCTE norms.
- (iii) Out of 9 Lecturers, six of them have not qualified NET/SLET. It is also not clear as to whether they qualify for the exemption of NET.
- (iii) List of teachers appointed in the institution has not yet been cleared by the affiliating University.
- (iv) It is not clear from the list of teaching staff provided by the institution as to whether arrangement has been made for part time instructors for teaching Arts and Craft, Music, Physical Education etc.
- (v) The library does not have encyclopedia
- (vi) The endowment fund is to be put under joint operation with a representative of NRC
- (vii) The teachers are being paid consolidated salaries and not in accordance with the scales of pay prescribed by UGC/State or Central Govt. In this regard.
- AND WHEREAS the said report of the inspection team and reply of the institution were placed before the NRC in its 80" meeting. Having considered the same, the Committee noted that no supporting documents have been attached with the reply. Therefore, the committee decided that a show cause natice may be issued to the Institution under section 17 of the NCTE Act 1993. Accordingly a show cause notice dated 08.08.2004 was issued to the Institution communicating therein the deficiencies observed by the visiting team on inspection made by it under section 13 of NCTE Act 1993
- The reply submitted by the Institution was placed before NRC in its 85th meeting held on C4th & 05th Nov. 2004, whereby the NRC decided that inspection of the Institution be corried out under section 17 of NCTE Act 1993 for verification of the facts in reply submitted by the Institution w.r.t. the deficiencies pointed above.
