ORDER

WHEREAS, Smt. Narayani Devi Verma Women's Teacher Training College, Mahila Ashram, Bhilwara, Rajasthan - 311001 was granted recognition to conduct B.Ed. course with an annual intake of 160 (One Hundred Sixty) seats with effect from the session 2001-2002 vide this office order No. F-3/RJ-05/97/1568-1573 dated 20.06.1998.

2. AND WHEREAS, NRC in its 86th meeting, in proceedings initiated under Section 17 of NCTE Act, 1993, decided to withdraw the above order granting recognition to the institution for B.Ed. course. Pursuant to it, a formal order dated 28.04.2005 was issued by the office of NRC.

3. AND WHEREAS, since National Council for Teacher Education vide its order dated 09.06.2005, in an appeal preferred before it, has reversed the above order of NRC.

4. AND THEREFORE, in pursuance of the order of NCTE, the NRC withdraws its order dated 28.04.2005 and the order issued by this office dated 20.06.1998 granting recognition to the institution for B.Ed. course is restored to continue and remain in force till further orders.
