## ORDER

**WHEREAS Meera Bai Women Training Institute, Mansar Khedi, Tehsil – Bassi, Jaipur, Rajasthan** was granted recognition by the Northern Regional Committee of NCTE for conducting Nursery Teachers Training (NTT) course of two year duration with an annual intake of 50 seats in the 1<sup>st</sup> year and the same for 2<sup>nd</sup> year from the academic session 2004-2005.

2. AND WHEREAS, the institution vide its letter dated 10.01.2006 intimated that they could not start the NTT Course and therefore requested to return the original FDR submitted alongwith application as Endowment Fund.

3. AND WHEREAS, the request was considered by the NRC in its 100<sup>th</sup> meeting wherein the committee decided to withdraw the recognition granted for conducting NTT Course on the request of the Institution and return the FDR to the institution.

4. NOW, THEREFORE, the recognition granted for NTT Course is withdrawn and request made by you to return the FDR towards Endowment Fund, the FDR No. 9763400 amounting Rs. 5.00 lakhs issued by the Bank of India is hereby returned with this order.

5. AND THEREFORE, **Meera Bai Women Training Institute, Mansar Khedi, Tehsil – Bassi, Jaipur, Rajasthan** and other concerned bodies are advised not to admit any student in **NTT** course in the said institute. In accordance to the Section 17(4) of NCTE Act, 1993 ***the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government.***
