ORDER

Mewar Institute of Management, Sector-4-C, Vasundhara, Ghaziabad, U.P. was granted recognition by Northern Regional Committee (NKC), Jaipur for starting B.Ed. course of one year with an annual intake of 100 students from the academic session 2002-2003 subject to certain condition vide order FNRC/NCTE/F-3/UP-611/2002/7607 dated September 29,2002

AND WHEREAS, the said institution has made an application seeking permission to start new course of B.E.C. vide communication dated 26.12,2003.

- 2. WHEREAS, in pursuance of complaint received from the Registrar, C.C.S. University, Meerut, U.P., inspection of the institution was got conducted under section 17 for B.Ed. course alongwith assessment for proposed B.T.C. course under section 15 of the NCTE Act, 1993 which was carried out on 09:09.2004 by the Inspection Committee.
- 3. AND WHEREAS, the Inspection Committee noted certain deficiencies in relation to B.Ed. course and also with regard to proposed course of B.T.C. Hence a Show Cause Notice dated November 11, 2004 was given to the Institution drawing its attention to the deficiencies in relation to B.Ed. course as well B.T.C. course with an opportunity to make representation against the proposed action.
- 4. After receipt of written representation of the institution vide letter dated 04.12.2004, the matter was placed before NRC in its 87th meeting, wherein, after careful perusal of the file of the Institution, original VTR and other related documents in the light of provisions of NCTF Act, 1993, Rules, Regulations, orders made or issued from time to time, it was decided to with-draw recognition for B.Ed. course after the current academic session i.e. 2004-2005 being satisfied of the deficiencies pointed out by the inspection Committee Pursuant to the decision taken by the NRC in its 87th meeting, recognition of Mewar Institute of Management, Sector-1-C, Vasundahra, Ghaziabad for B.Ed. course was withdrawn from the end of academic session 2004-2005 vide order F.NRC/NCTE/F-3/UP-611/2005/13577-13578 dated February 18, 2005.
- AND WHEREAS, the Regional Committee also decided in its 87th Meeting that permission/recognition to the proposed B.T.C. course be also not granted to the institution due to withdrawal of aforesaid recognition for the B.Ed. course.

AND THEREFORE, permission of 8-1.C. course is refused to Mewar Institute of Management, Sector 4-C, Vasundahra, Chaziabad, U.P. for the above reasons.
