RASEURA, SITAPUR-POST-26 VILLAGE SANSTHAN, SHIKSHA 261001, UTTAR PRADESH for B.ED. course with an annual intake of 100 seats, w.e.f. 11/082005 subject to compliance of the following conditions before commencement of the academic session.
 - Appointment of the faculty members duly qualified and staff as per the norms of NCTE/ State Govt./ UGC is to be completed before the commencement of the session.
 - The countersigned statement of all faculty members from the Registrar of the concerned University should be submitted before the commencement of the academic session.
 - The institution shall adhere to all the other regulations and guidelines as framed by NCTF from time to time.
 - The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five Years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
 - That the Roserve fund for an amount equal to three months salary of the Teacher & Staff be created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/ institution, for a period of not less than sixty months (Five Years) in a Nationalized Bank.

Non-compliance of the above mentioned conditions shall cause action under Section 17(1) of NCTE Act, 1993

- The recognition is subject to the condition that the affiliating University shall ensure that, among other things, the institution has appointed required number of 3. faculty members (including Principal/ Head of Department), as per the norms of the NCTE / UGC / Affiliating University.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc. 4
