## ORDER

WHEREAS, the institution, namely, Shri Bhrigunath Gangadhar Mahavidyalya, Village, Kharaila, PO Shivpur-Datiwad, Tehsil Bansdiah, District Ballia, U.P.- 277301 vide covering letter dated 31.12.2003 has made application to the Northern Regional Committee (in short NRC) of National Council for Teacher Education (for short NCTE) under Section 14(1) of NCTE Act, 1993 seeking recognition to start B.Ed. course from academic session 2004-2005. The application is accompanied by a No Objection Certificate (NOC) from the State Government containing one of the conditions that the institution for conducting the above course shall be established on land measuring 7.45 Acres, bearing Khasra number 45 and Khatoni No. 74 of village Mahui, Tehsil Bansdiah, District Ballia as shown in the name of applicant institution in the application seeking NOC.

Alongwith the application form the institution has submitted true copies of Revenue Record (Six yearly Khatoni) showing land of Khasra numbers 45 and 55 measuring 2.76 and 7.45 Acres situated at village Mahui and Bindwalia respectively in the name/khatedari of the institution. The said documents are verified on eath by the Manager of the institution, Shri Nagenra Pandey to be true and correct on the basis of personnel knowledge in the affidavit submitted by him, which is attested by SDM, Ballia.

- 2. AND WHEREAS, vide covering letter dated 05.06.2004, the institution submitted fresh true copies of Revenue Record (Six yearly Khotoni) showing land measuring 2.76 and 7.45 Acres bearing Khasra numbers 55 and 45 situated at village Mahui and Bindwalia respectively in the name of the institution and this fact is also certified in Land title Certificate issued by the local lawyer.
- 3. AND WHEREAS, the said application was in process of scrutiny, the NRC and NCTE received copy of complaint addressed to Vigilance Commissioner, Government of India containing serious allegations in respect of various aspects, including lack of infrastructural facilities and fabrication of land title documents by the institution.

4. AND WHEREAS, for verification of the facts, documents and other infrastructural and instructional facilities as per norms and standards laid down by the NCTE Regulations, 2002, a visiting team of experts, appointed by NRC, conducted inspection of the institution. The said team sought verification about title and measurements of the above lands of Khasra numbers 45 and 55 from the concerned Tehsildar by sending copies of the Revenue Records submitted by the institution. In compliance, the concerned Tehsildar vide its letter dated June 6, 2005 intimated the visiting team that Khatoni No. 97 relates to Khasra No. 39 in the name/khatedari of Davendra S/o Shri Kashinath of Shivpur, while Khatoni No. 91 relating to Khasra number 45, the land measuring 1.84 Acres (0.745 Hects) only is in the name/khatedari of the institution. In other words, the land documents as submitted by the institution were incorrect and false, appears to have been got prepared in manipulation.

The net effect is that no land of Khasra No. 55 is in the name/khatedari of the institution, while land measuring 1.84 Acres only of Khasra number 45 of Khatoni No. 91 is in the name of the institution and copies of Revenue Records submitted for seeking NOC and before the NRC alongwith application form and subsequently vide letter dated 05.06.204 are in correct and false with deliberate design to misguide the authorities concerned. It further shows that the condition regarding land subject to which NOC was granted is also violated.

- 5. AND WHEREAS, the entire matter was considered by NRC in its 93<sup>rd</sup> meeting, including the above defects and other defects pointed out by the visiting team and after being satisfied the Committee decided to give a show Cause Notice, providing reasonable opportunity to the institution to make written representation before rejecting the application seeking recognition to start B. Ed. course. Consequently, the institution was intimated vide NRC's communication dated 05<sup>th</sup> July, 2005, wherein the facts relating to the land title documents and other defects notified were pointed out to the institution. The communication was replied by the institution vide its letter dated 03.08.2005.
- 6. AND WHEREAS, the entire matter including the representation made by the institution was again considered by the NRC in its 96<sup>th</sup> meeting held on 20<sup>th</sup> and 21<sup>th</sup> September, 2005 wherein it was decided to reject the application and close the file of the institution.
- AND THEREFORE, In terms of above decision of NRC, the application of the above institution seeking recognition to start B. Ed. course is hereby rejected/refused under section 14 (3) (b) of the NCTE Act, 1993.
- 8. Consequently, the institution shall not admit any student in B. Ed course and the examining body shall not grant affiliation to the institution or hold examination, whether provisional or otherwise for the B. Ed. Course, if conducted by the said institution unless the institution is granted permission for the said course by the NRC/NCTE.
