Geeta Bajaj Pre-Primary Mahila Shikshak Prashikshan Vidyalaya, Mooti Doongri, Jaipur - 302004, Rajasthan submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition of additional intake in its Pre-Primary course of two Year duration in terms of section 15(1) of NCTE Act, 1993.

- Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Geeta Bajaj Pre-Primary Mahila Shikshak Prashikshan Vidyalaya, Mooti Doongri, Jaipur - 302004, Rajasthan with an additional Intake of 50 (Fifty) seats in the Pre-Primary Course of two year duration thereby making the annual intake of the institution to 100 (One Hundred) in the 1st year and the same for the 2"d year w.e.f. 21st September, 2005 subject to compliance of the following conditions before commencement of the academic session.
 - a. Appointment of the faculty members duly qualified and staff as per the norms of NCTE/ State Govt./UGC is to be completed before the commencement of the session.

b. The countersigned statement of all faculty members from the Director, SCERT should be submitted before the commencement of the academic session.

c. The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.

d. The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.

e. That the Reserve Fund for an amount equal to three months salary of the leachers & Staff be created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five years) in a Nationalized Bank.

f. Non-compliance of the above mentioned conditions shall cause action under section 17 (1) of NCTE Act, 1993.

Further, the recognition is subject to fulfillment of all such other requirements. as may be prescribed by other regulatory bodies like UGC and State Government, etc.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
