ORDER

WHEREAS, the institution, namely, V.K. Jain College of Education, Saran Road, Kasganj, Etah, Uttar Pradesh has made application seeking permission to start Elementary Teacher Education (ETE) programme from academic session 2004-2005 and the same is received in the office of NRC on 02.04.2004. However, on preliminary scrutiny, the application was found incomplete i.e. without all the essential documents, hence, the application was carried forward for subsequent academic year i.e. 2005-2006 by the NRC vide its communication/letter No. F. NRC/NCTE/F-3/UP-1567/2004/2623 dated 01.06.2004.

2. AND WHEREAS, inspection of the Institution by a team of experts was made on July 15, 2005, wherein certain deficiencies were pointed out.

3. AND WHEREAS the matter was considered by NRC in its 94th meeting held on 22nd and 23rd July, 2005, wherein it was decided to give a reasonable opportunity to the institution to make written representation before the application is refused on account of the deficiencies. In pursuance thereof, the Institution was intimated deficiencies by the NRC vide its letter No. F. NRC/NCTE/F-3/UP-1567/2004/7956-7959 dated 08th August, 2005 and giving an opportunity to the institution to make written representation with documentary proof duly certified by the competent authority with reference to each deficiency alongwith an affidavit testifying the contents of the reply.

4. AND WHEREAS, the Institution has submitted its reply to the NRC vide letter dated Nil, received in the office of NRC on 02.09.2005 and the entire matter was considered by the NRC in its 96th meeting held on 20th and 21st September, 2005 and noting that the Institution has not complied with the deficiency by creating a Reserve Fund equivalent to three month salary of the staff as required by the NCTE Regulations, 2002, the Committee decided to refuse the above application.

5. AND THEREFORE, in terms of above decision of NRC, the application of the institution seeking permission for the Elementary Teacher Education (ETE) course is refused under section 15 (3) (b) of the NCTE Act, 1993.

6. Consequently, the institution shall not admit any student in Elementary Teacher Education course and examining body shall not hold examination, whether provisional or otherwise for the Elementary Teacher Education course if conducted by the said institution unless the institution is granted permission for the said course by the NRC/NCTE.

7. In accordance with section 17 (4) of the NCTE Act, 1993, the qualification in teacher education, namely Elementary Teacher Education, obtained pursuant to such course or training in the above institution shall not be treated as valid qualification for purpose of employment under the Central Government, any State Government or University, or in any School, College or other educational body aided by the Central Government or any State Government.

8. Further, if the institution is not satisfied by this order, it can prefer an appeal before National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of NCTE Act, 1993, within 60 days of the date of issue of this order. The guidelines for appeal are enclosed herewith.
