ORDER

WHEREAS, the institution, namely, Ramo College of Education, 224, Arya Neger, Suraj Kund Road, Mecrut - 250001, Uttar Pradesh has applied for Elementary Teacher Education (ETE) programme from the academic session 2004-2005 and the same is received in the office of NRC on 30.1.2004. However, the said application was carried forward for the subsequent academic year by the NRC vide its communication/letter No. F. NRC/NCTE/F-3/UP-1484/2004/1455 dated 10.05.2004.

- AND WHEREAS, after inspection of the institution, the matter was considered by NRC in its 93rd meeting, wherein it was decided that for the deficiencies noted, the institution be given a reasonable opportunity for making a written representation. Pursuance thereof, the NRC vide its letter No. F. NRC/NCTE/F-3/UP-1484/2004/\$125-5129 dated 05" July, 2005 gave opportunity to the institution to make written representation drawing its attention to the deficiencies, which included non creation of the Reserve Fund equivalent to three months salary of the staff as required by NCTE Regulations, 2002.
- 3. AND WHEREAS, the institution has submitted its reply to the NRC vide letter No. 1 dated 11.08.2005, wherein a photo copy of Fixed Deposit receipt riated 26.10.2004 for deposit of Rs. 3.00 Lacs by Rama Social Reforms and Educational Society, Meerut is attached.
- AND WHEREAS, the entire matter was considered by the NRC in its 96" meeting held on 20" and 21" September, 2005. On careful perusal of the original file of the institution, the reply dated 11.08.2005 submitted by the institution alongwith documents etc., it was noted by the NRC that the Fixed Deposit receipt of Reserve Fund for the proposed ETE course is the same as submitted for B. Ed. course and as such, no Reserve Fund is created for the proposed teacher training programme of C1F. The NRC, therefore, decided to refuse the said application.
- AND THEREFORE, in terms of shove decision of NRC, the application of the institution seeking permission for the Elementary Teacher Education (FTE) doorse is refused under section 15 (3) (b) of the NCTE Act, 1993.
- Consequently, the institution shall not admit any student in Elementary Teacher Education (BTC) course and examining body shall not hold examination, whether provisional or otherwise for the said course if conducted by the institution unless it is granted permission for the said course by the NRC/NCTE.
