Mahavidyalaya, Mehrban Singh Ka Purva, WHEREAS, Shivlok Mahila Post - Mardanpur, Distt. - Kampur Nagar -208001 (U.P.) had applied for grant of recognition (code no. APN 02135) for 200 intake in BTC course of two years duration under section 15(1) of the NCTE Act, 1993 to the NRC, NCTE.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- AND WHEREAS in its 99th meeting held on 22-23 December 2005 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution , is satisfied that the applicant institution does not fulfill the requirements and issued a notice on 13.01,2006 to the applicant institution under provision to section 15(3)(b) of the NCTE Act, 1993, thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.
- AND WHEREAS the applicant institution had submitted representation dated 19,12,2005 to NRC, NCTE. The said representation of the institution as well as other documents and materials submitted by the institution along with VTR and videography were again duly considered by the Northern Regional Committee on 13-17 July 2006, which came to the conclusion that recognition/permission, to the said institution be refused for the following reasons.
- The institution has not yet started the process of appointing the staff for the (a) proposed BTC programme.

Building/infrastructural space is under construction. (b)

Instruments/equipments for psychology lab not provided. (c)

OHP not provided. (d)

Internet facility not provided. (e)

The books available in the library is only 1000, whereas the NRC is of the view that a (f) minimum of 1500 books in addition to the books for B.Ed. course, are required for the effective curricular transaction for BTC course.

Educational journals have not yet been purchased. (g)

No books have been purchased for the proposed BTC course. (h)

Encyclopedia not provided for existing as well as proposed programme. (1)

Reserve fund for proposed programme not provided. (1)

- 5. NOW, THEREFORE grant of recognition /permission to Shivlok Mahila Mahavidyalaya, Mehrban Singh Ka Purva, Post Mardanpur, Distt. Kanpur Nagar -208001 (U.P.) for the course in BTC in terms of section 15(3) (b) of the NCTE Act, 1993, is hereby refused.
- If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
