### ORDER

- 3. The institution shall ensure the fulfillment of the following:-
- (a) The institution shall maintain the teaching staff strength of 1+7 for the proposed B.Ed. Course.
- The institution shall note that with regard to NET/SLET requirement, the (b) relaxation is allowed only upto the year 2009-2010 as per NCTE Regulation dt. 21.07.2006.
- The institution shall adhere to all the other regulations and guidelines as (c) framed by NCTE from time to time.
- (d) The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not loss than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
- (c) That the Reserve Fund for an amount of Rs. Three Lakhs be maintained in the form of FDR in favour of the management/institution.
- Further, the recognition is subject to fulfillment of all such other (f) requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
- The institution shall submit to the Regional Committee a Self-Appraisal (a) Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
