- 3. The institution shall ensure the fulfillment of the following:-
- Selection of qualified staff through duly constituted selection committee as (a) per the norms of NCTE/State Govt./ Affiliating University given effect before the commencement of the course.
- The institution shall maintain the teaching staff strength of 1+3 for the (b) proposed M.Ed. Course.
- The Institution shall note that with regard to NET/SLET requirement, the (c) relaxation is allowed only upto the year 2009-2010 as per NCTE Regulation dt. 21.07.2006.
- (d) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- (e) The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
- That the Reserve Fund for an amount of Rs. Three Lakhs be maintained in (f) the form of FDR in favour of the management/institution.
- Further, the recognition is subject to fulfillment of all such other (g) requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
- The institution shall submit to the Regional Committee a Self-Appraisal (h) Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
