- (a) The institution shall maintain the teaching staff strength of 1+5 for the proposed BTC Course.
- The Institution shall adhere to all the other regulations and guidelines as (b) framed by NCTE from time to time.
- The institution shall within one month of the receipt of Recognition order, (c) convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
- That the Reserve Fund for an amount of Rs. Three Lakhs be maintained in (d) the form of FDR in favour of the management/institution.
- (e) Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
- The institution shall submit to the Regional Committee a Self-Appraisal (f) Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
