- The Institution shall ensure the fulfillment of the following:-5.
- Selection of qualified staff through duly constituted selection committee as per (a) the norms of NCTE / State Govt. / Affiliating University/SCERT given effect before the commencement of the course.
- The institution shall maintain the teaching staff strength of 1+5 for the proposed (b)
- The institution shall adhere to all the other regulations and guidelines as framed (c) by NCTE from time to time.
- The institution shall within one month of the receipt of Recognition order, convert (d) the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
- That the Reserve Fund for an amount of Rs. Three Lakhs be maintained in the (e) form of FDR in favour of the management/institution.
- Further, the recognition is subject to fulfillment of all such other requirements as (f) may be prescribed by other regulatory bodies like UGC and State Government, etc.
- (a) The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered

(h). The institution shall regularly update its website.
