ORDER

**Laxmi College of Education, Kasan Road, Village + Post - Maneshar , Gurgaon, (Haryana)** submitted an application to the Northern Regional Committee of National Council for Teacher Education for permission of **B.Ed Course** in terms of section **14 (1) of NCTE Act, 1993.**

2. The NRC at its 108<sup>th</sup> meeting held on 25-26 September 2006 at NRC, NCTE Jaipur considered application of the institution including in the agenda for the meeting and after careful examination of relevant documents, visiting team reports, Video Recording etc. found the institution fit for grant of recognition.

3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants permission to **Laxmi College of Education, Kasan Road, Village + Post - Maneshar , Gurgaon, (Haryana)** to conduct **B.Ed. Course** of One-year duration **w.e.f. the session 2006-2007** with an annual intake of **100 (One Hundred Only) (One Unit)**, subject to appointment of staff as per Regulations and ratification by the University at the following address :-

**Laxmi College of Education,  
Kasan Road, Village + Post - Maneshar ,  
Gurgaon, (Haryana)**

4. The institution shall ensure the fulfilment of the following :-

- a. The institution shall maintain the teaching staff strength of **1+7 for the B.Ed. Course.**
- b. The institution shall note that with regard to NET/SLET requirement, the relaxation is allowed only upto the year 2009-2010 as per NCTE Regulation dt. 21.07.2006.
- c. The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- d. The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
- e. That the Reserve Fund for an amount of Rs. Three Lakhs be maintained in the form of FDR in favour of the management/institution.
- f. Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
- g. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
- h. The institution shall regularly update its website.

5. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and/or order made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act, 1993.
