WHEREAS, SRM Institute of Management & Technology, Delhi Meerut Road, Sikri Kalan, Modi Nagor, Ghaziabad, Uttar Pradesh, which was granted recognition for an annual intake of 100 seats for running 8.Ed course from the academic session 2004-06 subject to fulfillment of following before the commencement of the session wide this office order no. F. NRC/NCTE/F-3/UP-1205/3462-3470 dated 06.07.2004

- (a) Appointment of the faculty members duly qualified and staff as per the norms of NCTE/ State Govt./UGC is to be completed before the commencement of the session.
- (b) The countersigned statement of all faculty members from the Registrar of the concerned University should be submitted before the commencement of the academic session 2004-2005.
- (c) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- (d) The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund occurre into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
- (e) That the Reserve Fund for an amount equal to three months salary of the Teacher & Staff be created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five Years) in a Nationalized Bank.
- (f) Non-compliance of the above mentioned conditions shall cause action under section 17 (1) of NCTE Act, 1993.
- 2 AND WHEREAS, SRM Institute of Management & Technology, Delhi Mecrut Road, Silvi Kalan, Modi Nagar, Ghoziabad, Uttar Pradesh at the time of granting recognition by NCTE was affiliated with CCS University, Mecrut (UP).
- 3. AND WHEREAS, SRM Institute of Management & Technology, Delhi Meerut Rood, Sikri Kalan, Modi Nagar, Ghaziabad, Uttar Prodesh has been included with SRM Institute of Management & Technology (Deemed University) under ambit of SRM institute of Science & Technology, Chennal (Deemed University) vide Ministry of HRD, Department of Secondary & Higher Education, New Delhi, notification dated 28.01.2005 w.e.f. 18.01.2005 subject to review after 3 years
- 4. AND WHEREAS, in the light of aforesoid notification the institution "SRM Institute of Mutagement & Technology, Delhi Meerut Road, Sikri Kalan, Madi Nagar, Ghaziabad, Uttar Pradesh" had requested for a change in the affiliation from CCS University, Meerut (UP) to SRM Institute of Management & Technology, Chennai (Deemed University).
- 5. AND WHEREAS, the Northern Regional Committee (NRC) in its 101" meeting decided to accept the request of the institution seeking Charge in the affiliating body subject to the fulfillment of Rules & Regulations of University Grant Commission of Deemed University.
