

ORDER



- The Institution was inspected on 10.07.2004 by an inspection team of expert constituted by NRC. The inspection team noted certain deficiencies in its report submitted and the same was considered by NRC in its 80th meeting held on 26th - 27th July 2004 alongwith the original file of the institution.
- 3. After careful perusal of the file, inspection Report of the experts and other related documents, the committee, in the above meeting, being satisfied that the Institution did not fulfill the requirements laid down in sub clause (a) of section 15(3) of NCTE Act, 1993 decided that the Institution be given a reasonable opportunity for making representation drawing its attention with following deficiencies existed vis à-vis NCTE Norms:
 - Science lab is not available.
 - Multiple set of apparatus not provided in Science lab.
 - Chemicals and Consumable in the required quantity have not been procured.
 - The Science lab facilities are not adequate.
 - Instruments for simple experiments related to educational psychology have not been procured.
 - The facilities in the psychology lab are not adequate.
 - Educational Technology lab not provided.
 - List of facilities/equipments/A-V alds especially for BTC programme for ET lab which is proposed to be shared with engineering college.
 - The Institution has not created library facilities.
 - Books not available in the library.
 - Educational journals not provided.
 - List of staff for B.Ed programme duly approved by the affiliating university.
 - The Institution has not made any preparation regarding curriculum transaction of ETE programme namely availability of books, library, equipments/apparatus, psycho-test etc. specifically related to elementary education. The staff has not been appointed through duly constituted selection committee.

Consequent upon the above decision, letter no. F.NRC/NCTE/F-3/UP-408/2004/5395 dated 07.08.2004 was issued communicating the above deficiencies to the Institution with an opportunity to make representation within one month before passing an order refusing permission to the new course of BTC.

4. The institution submitted its written representation vide letter dated 24.08.2004. The said representation was placed before the NRC in its 83rd meeting held on 14th - 15th September 2004 wherein the Complete, after consideration of the entire matter noted that the affidavit has not been submitted by the institution. The institution be asked to clarify the reasons for not submitting the affidavit and to submit the same.
