ORDER

WHEREAS SES Model College of Education, K.K. Road, Dhoom Manikpur, Tehsil – Dadri, Distt. – Gautam Budh Nagar, U.P. had applied for grant of recognition (UP - 2084) for BTC course two years(s) duration under section 15(i) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit
 the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS in its 110th meeting held on 10-12 Nov 2006 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on 20.11.2006 to the applicant institution under provise to section 15(3)(b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.
- 4. AND WHEREAS the applicant institution had not submitted any representation to Northern Regional Committee, NCTE. The said representation of the institution as well as other documents and materials submitted by the institution along with VTR and videography were again duly considered by the NRC on 28-30 July 2007 which came to the conclusion that recognition to the said institution be refused for the following reasons.

(a) Playground is not provided.

- (b) CD Roms, Internet not provided in ET lab.
- (c' hollities for language learning not provided,

(o) userve fund not provided.

(e) The number of books added in the library is only 756, whereas the visiting team is of the view that a minimum of 1500 books are required for effective curriculum transaction.

(f) Appropriate psychological tests for children are required.

- (g) The institution to appoint the qualified staff by a duly constituted selection committee as per NCTE Norms/State Govt./Affiliating University.
- NOW THEREFORE grant of recognition to SES Model College of Education,
 K.K. Road, Dhoom Manikpur, Tehsil Dadri, Distt. Gautam Budh Nagar, U.P.
 for the course in BTC in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused.
