NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to **Dev Education College, Barhan, Etmadpur, Agra-283201**, **U.P.** for conducting **B.Ed.** Course of One year duration with an annual additional intake of 100 (One Hundred Only) (Existing 200 + Additional 100 = 300) students under clause 7(12) of Regulation dated 13-1-2006 subject to fulfillment of the following:
  - (i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
  - (II) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time...
