Course of One year duration with an annual additional intake of 100 (One Hundred Only) (Existing 150 + Additional 100 = 250) students under clause 7(12) of Regulation dated 13-1-2006 subject to fulfillment of the following:
  - The institution shall, within one month of the receipt of recognition (1) order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
  - The institution shall comply with the various other norms and (ii) standards prescribed in the NCTE regulations, as amended from time to time...
