

WHEREAS in terms of Section 14 (1) he NCTE Act, 1993, Shakti Smarak Sansthan, Village - Dulhinpur, Post-Balrampur, Distt. - Balrampur-271201, U.P. has submitted an application (code No. APN04211) to the Northern Regional Committee of NCTE for grant of recognition/permission for starting B.Ed. - NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition Shakti Smarak Sansthan, Village - Dulhinpur, Post-Balrampur, Distt. - Balrampur-271201, U.P. for conducting B.Ed. Course of One year duration with an annual intake of 100 (One Hundred Only) students under clause 7(12) of Regulation dated 13-1-2006 subject to fulfillment of the following:
 - The institution shall, within one month of the receipt of recognition (1) order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
 - The institution shall comply with the various other norms and (H) standards prescribed in the NCTE regulations, as amended from time to time.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc, wherever applicable.
