

ORDER

WHEREAS in terms of Section 14 (1) of the NCTE Act, 1993 5.S. - NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to 1993 S.S. College of Education, VIII- Kutana, Shiv Nagar, Rohtak, Haryana for conducting B.Ed. Course of one year duration with an annual intake of 100 (one Hundred Only) students under clause 7(12) of Regulation dated 13-1-2006 subject to fulfillment of the following:
- The Institution shall, within one month of the receipt of recognition (1) order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
- (ii). The Institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- 4) Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc, wherever applicable.
