WHEREAS In terms of Section 14 (1) of the NCTE Act, 1993 Haryana College of B.Ed, Mudhai Road, Sokhi, Tehshil-Hansi, Distt- Hissar, Hayana has submitted an application (code No.04354) to the Northern Regional Committee of NCTE for grant of recognition/permission for starting B.Ed. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to 1993 Haryana College of B.Ed, Mudhai Road, Sokhi, Tehshil-Hansi, Distt-Hissar, Hayana for conducting B.Ed. Course of one year duration with an annual intake of 100 (one Hundred Only) students under clause 7(12) of Regulation dated 13-1-2006 subject to fulfillment of the following:
  - (i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
- (ii). The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- Further, the recognition is subject to fulfillment of all such other requirements
  as may be prescribed by other regulatory bodies like UGC and the State
  Government etc, wherever applicable.
