ORDER

WHEREAS in terms of Section 14 (1) of the NCTE Act, 1993 **Balaji College of Education, Adarsh Nagar, Ballabgarh-121004, Haryana** has submitted an application (code No.04077) to the Northern Regional Committee of NCTE for grant of recognition/permission for starting **B.Ed. Course** of one year duration with an annual intake of **100(One Hundred Only)** students.

2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Secondary Teacher Education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to **Balaji College of Education, Adarsh Nagar, Ballabgarh-121004, Haryana** for conducting B.Ed. Course of one duration with an annual intake of 100(One Hundred Only) students under clause 7(12) of Regulation dated 13-1-2006 subject to fulfillment of the following:

- (i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
- (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc, wherever applicable.

ORDER

Shri Satya Sai College of Education, Village Khola (NADAUN), Distt. Hamirpur – 177 033, Himachal Pradesh submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition of B. Ed course in terms of Section 14 (1) of NCTE Act, 1993.

2. Now, therefore, in exercise of powers vested under Section 14 (3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **Shri Satya Sai College of Education, Village Khola (NADAUN), Distt. Hamirpur – 177 033, Himachal Pradesh** to conduct B. Ed course of One year duration with an annual intake of 100 (One Hundred only) (One Unit) w.e.f. the session 2006-2007 at the following address :-

3. The institution shall ensure the fulfillment of the following :-

- (a) The institution shall maintain the teaching staff strength of 1+7 for the proposed B. Ed Course.
- (b) The institution shall note that with regard to NET / SET requirement, the relaxation is allowed only upto the year 2009-2010 as per NCTE Regulation dt. 21.07.2006.
- (c) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- (d) The institution shall within one month of the receipt of Recognition order, convert the Endowment fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalised Bank only to be operated along with an official of the Regional Committee.
- (e) That the Reserve Fund for an amount of Rs. Three Lakhs be maintained in the form of FDR in favour of the management / institution.
- (f) Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government etc.
- (g) The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
- (h) The institution shall regularly update its website.
