The institution shall note that with regard to NET / SLET requirement, the relaxation is allowed only upto the year 2009-2010 as per NCTE (b) Regulation dt. 21.07.2006.

The institution shall adhere to all the other regulations and guidelines as (c)

framed by NCTE from time to time.

- The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of (d) FDR for a period of not less than 60 months (Five years) in a Nationalised Bank only to be operated along with an official of the Regional Committee.
- That the Reserve Fund for an amount of Rs. Three Lakhs be maintained in the form of FDR in favour of the management / institution. (c)
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC (1) and State Government etc.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval (11) of the effiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.


