- (iii) In case of photocopies of documents enclosed along with the application and check list, the same needs to be verified with the original documents available with the Institution /management. Wherever discrepancies are noted, the same needs to be recorded either at the appropriate column of the Inspection Report or at the space earmarked for comments. Please do not get the signatures of Principal or any other representative on the assessment Performs, However, please get signatures with seal of the institution of whatever information/detail is given by them.
- (iv) Since the land is to be free from any encumbrances, an affidavit to this effect is to be submitted by the management verifying.
