  - The Institution shall, within one month of the receipt of recognition (1) order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
  - (ii). The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
