Course of One year duration with an annual additional intake of 100 (One Hundred Only) (Existing 100 + Additional 100 = 200) students under clause 7(12) of Regulation dated 13-1-2006 subject to fulfillment of the following:
  - The institution shall, within one month of the receipt of recognition order, (1) convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
  - The institution shall comply with the various other norms and standards (H) prescribed in the NCTE regulations, as amended from time to time.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc. wherever applicable.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
