The institution shall within one month of the receipt of Recognition order, (e) convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.

That the Reserve Fund for an amount of Rs. Three Lakhs be maintained in (f)

the form of FDR in favour of the management/institution.
