- 3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Yaduvanshi Institute of Education, Salimabad, Bucholi Road, Distt-Mohindergarh, Haryana for conducting B.P.Ed. Course of one year duration with an annual intake of 50 (Fifty only) students under clause 7(12) of Regulation dated 13-1-2006 subject to fulfillment of the following:
 - (i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
 - (ii). The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc, wherever applicable.
- The Institution shall submit to the Regional Committee a Self-Appraisal Report
 at the end of each academic year along the statement of annual accounts duly audited
 by a Chartered Accountant.
