ORDER

V-Tech Institute of Integrated Technology, Near Chakor Zoo, Post - Agriculture School, G.T. Road, Bulandshahar, Uttar Pradesh submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for BTC course in terms of section 15(1) of NCTE Act, 1993.

Now, therefore, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **V-Tech Institute of Integrated Technology, Near Chakor Zoo, Post - Agriculture School, G.T. Road, Bulandshahar, Uttar Pradesh** for an annual intake of 50 seats (fifth only) (30 seats in the 1st year and the same for the 2nd year) in BTC course of two year duration with effect from the academic session 2006-2007 at the following address:-

3. The institution shall ensure the fulfillment of the following:
 - (a) The institution shall maintain the teaching staff strength of **1+5 for the BTC Course.**
 - (b) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
 - (c) Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
 - (d) The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
 - (e) The institution shall regularly update its website.
4. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and/or order made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act, 1993. The NCTE Regs. may also cause inspections under Section 13 of NCTE Act, 1993.
