WHEREAS in terms of Section 15 (1) of the NCTE Act, 1993 Shri Sardari Lal College of Education, Tehsil- Mullana, Vill and Post-Nahoni, Distt- Ambala, Haryana has submitted an application (code No.03430) to the Northern Regional Committee of NCTE for grant of recognition/permission for starting B.Ed. course of one year duration with an annual intake of 100(One Hundred Only) students.

AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Secondary Teacher Education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.
 - 3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Shri Sardari Lai College of Education, Tehsil- Mullana, Vill and Post-Nahoni, Distt- Ambala, Haryana for conducting B.Ed. course of one duration with an annual intake of 100 (One Hundred Only) students under clause 7(12) of Regulation dated 13-1-2006 subject to fulfillment of the following:
 - (i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
 - (ii). The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- 4. The principal is retaired and as per his date of birth he may continue for two years. Hence the institution is directed to appoint qualified principal within two year form the date of the issue of the Order and report to the NRC, NCTE with complete details on the prescribed format. If the institution fails to appoint qualified principal within the stipulated time necessary action will be taken as it deems fit under the provision of the NCTE Regulation.

- 6. The Institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- 7. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
- 8. The institution shall maintain & update the Web-site as per provisions of NCTE Regulations.
