NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Minerva College of Eudcation, Railway Road, Taraori (Karnal) Haryana for conducting B.Ed. course of one duration with an annual intake of 100 (One Hundred Only)) students under clause 7(12) of Regulation dated 13-1-2006 subject to fulfillment of the following:
 - (i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
 - (ii). The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- 4. The principal is retired and after six months, he is going to complete 65 yers. Hence the institution is directed to appoint qualified principal and furnish the details of his/ her qualififcations and experience within six months from the date of issued of this order failing to which the NCTE shall take an appointment under the norms of NCTE Regulation as it deemed fit.
